- Additional input is gathered annually from site level Parent Advisory groups such as SSC, DAC, and ELAC.

Involvement of Parents in the Title I Program

To involve parents and family members in the Title I program, the following practices have been established:

Castle Park Middle School convenes an annual meeting, at a convenient time, to which all parents of participating children shall be invited to attend and encouraged to attend, to inform parents and family members of their school's participation in the Title I program and to explain the requirements, and the right of the parents to be involved. Castle Park Middle School offers a flexible number of meetings, such as meetings in the morning or evening, and may provide, with Title I funds, transportation, child care, or home visits, as such services relate to parent involvement. (ESSA Section 1116[c][2])

- Quarterly Parent meetings held in both morning and evening for parents to provide information regarding various school Programs.
- All Parent Meetings and trainings are provided to Parents virtually or in person.
- Parent Meeting presentation and recordings are posted on the school website for Parents.
- Childcare is available to Parents that attend the meetings.

- All Parents are provided access to the Infinite Campus Parent Portal. The Campus Portal contains student credits, grades, progress reports and messages/information shared by teachers.

 School holds curriculum and program information nights to provide parents information regarding programs and alignment to State standards. Such as Counselor meetings by grade level, Curriculum nights, specific school program informational nights

- Parents are invited to attend monthly Coffee with the Principal meetings. During these meetings,
 parents are given opportunities to provide feedback regarding programs affecting the education of
 their children. Feedback from Parents is shared at monthly Parent Advisory Group meetings such as SSC
 and ELAC.
- Counselors and Teachers meet with Parent regularly upon request to discuss the progress of their children.
